Process

- Legislature gives authority for bonding through legislation.
- Building Authority works with state agencies, Bureau of Finance and Management and financial advisor to issue bonds.
- State agencies enter into a lease with South Dakota Building
 - Authority. Lease rental payments are used by the Authority
 - to make the bond payments.

Credit Ratings

- The State of South Dakota has AAA ratings from the 3 major rating agencies, 1 of 13 states to have AAA ratings from all 3 major rating agencies.
