# South Dakota Department of Health Federal Funding Summary

# **Overview:**

South Dakota's Department of Health received \$74.4 million in federal dollars through the CARES Act and redirection of existing funding. SDDOH was tasked with various activities in response to the COVID-19 pandemic. These funds were in addition to any funds that were allocated to the SDDOH from the Coronavirus Relief Fund.

# **Breakout:**

## Immunization- \$263,150

Purpose: Enhance influenza vaccination coverage as a critical part of COVID-19 response. A portion of this funding must be used to include a specific focus on enhancing influenza vaccination coverage and enrolling and working with additional vaccinators.

### Ryan White Part B- \$50,000

Purpose: Provide support to people with HIV served by the Ryan White Program with COVID testing and related services.

### Title 18/Medicare Survey & Certification- \$551,088

Purpose: Supplemental Medicare funding for Survey and Certification activities related to COVID-19 response, prioritizing nursing homes in locations with coronavirus community spread.

#### Rape Prevention & Education- \$9,273

Purpose: Enhance existing approved activities including virtual/on-line implementation, evaluation and dissemination of strategies that address the most pressing COVID-19 related violence issues.

<u>Public Health Emergency Response & Public Health Emergency Preparedness program- \$4,567,500</u> Purpose: General response activities relating to COVID-19 outbreak including surge staffing, purchase of personal protective equipment(PPE), laboratory equipment, and medical supplies.

#### Small Rural Hospital Improvement Plan- \$3,456,997

Purpose: Support for rural hospitals to meet the needs of patients with COVID-19.

## Hospital Preparedness Program COVID Supplemental I- \$350,752

Purpose: Support to the health care system to identify, isolate, assess, transport, and treat patients with COVID-19 or patients under investigation for COVID-19.

#### Hospital Preparedness Program (HPP) COVID Supplemental II- \$1,202,283

Purpose: Physician services to manage patient facility assignments so that EMS and hospitals do not need to transfer patients.

Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Infectious Diseases CARES 2020- \$5,075,000

Purpose: Establish and monitor key activities related to COVID-19 in the areas of epidemiology, laboratory, and informatics. Monitoring the indicators associated with these activities are intended to assist State, local, and territorial governments in making data-driven policy decisions regarding testing, mitigation, and prevention efforts.

Paycheck Protection Program, and Healthcare Enhancement Act- Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Infectious Diseases 'Project E'- \$57,932,604 Purpose: Develop, purchase, administer, process, and analyze COVID-19 tests, conduct surveillance, trace contacts, and related activities.

Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Infectious Diseases Project Firstline 'Project F'- \$892,363

Purpose: Funding for Project Firstline - CDC's new national training collaborative for Healthcare Infection Prevention and Control.

Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Infectious Diseases Surveillance 'Project O'- \$50,000

Purpose: Expand surveillance activities to include Multisystem Inflammatory Syndrome in Children.
