The South Dakota Economy

GDP by State

- During 2013, South Dakota's economy registered strong growth as the current dollar Gross Domestic Product (GDP) by state totaled \$46.7 billion, a growth of 6.8% over 2012. This growth was 4th highest of all states and compares to the US growth of 3.5% over the same time period.
- South Dakota's real (inflation adjusted) GDP by state in 2013 increased at a rate of 3.1%, 9th highest growth rate among all states and was higher than the national average growth of 1.8% on an inflation adjusted basis.
 - The largest contributor to growth in real GDP was from the agriculture industry, which grew 14.4% in 2013 as the Ag economy rebounded from the 2012 drought.

Employment growth in South Dakota

- On an annual basis during 2013, South Dakota nonfarm employment levels were 3,100 jobs higher than 2012, or an increase of 0.7% after annual benchmark revisions.
- In June 2014, total SD nonfarm employment was up 2,900 jobs or 0.7%, compared to June 2013.
 - Sectors that are currently experiencing year-over-year growth (June 2014 compared to June 2013 levels) include: professional and business services (+4.4%); logging, mining, and construction +1.9%); trade, transportation, and utilities (+1.1%); other services (+0.6%); manufacturing (+0.5%); and, government (+2.2%).
 - Sectors currently experiencing year-over-year declines include: financial activities (-0.7%); education and health services (-1.2%); and, leisure and hospitality (-2.0%).

The unemployment rate continues to be one of the lowest in the nation.

- The unemployment rate in South Dakota was the fifth lowest in the nation in June at 3.8%.
 - SD's unemployment rate in June was the same as last month and 0.1% lower than a year ago.
- The U.S. unemployment rate was 6.1% in June 2014.

Income growth in South Dakota.

- South Dakota's preliminary total personal income for 2013 increased 1.8% compared to 2012. The soft growth rate realized is partially attributed to a decrease in farm income in 2013.
 - In 2013, South Dakota's farm income decreased 6.0% compared to 2012. South Dakota's nonfarm income grew by 2.5% in 2013 compared to 2012, which was the same as the US growth rate of 2.5% over the same time period.
- Over the past three years (2010-2013), the average annual growth of South Dakota's personal income was 5.1%, which was 9th highest of all states. This compares to the US growth in total personal income of 4.3% over the same time period.
- South Dakota's preliminary per capita personal income in 2013 was \$45,558, which ranked 21st in the nation, and was 2.3% higher than the US per capita personal income of \$44,543 during 2013.

The housing market.

- In the last twelve months (July 2013 June 2014) there were 151 more total family housing units authorized by building permits in South Dakota than there were the same period before.*
- The value of total family housing building permits is \$43.30 million higher in the last twelve months compared to the same period the year before. *

The agricultural economy.

- South Dakota farm real estate, including land and buildings, averaged \$2,070 per acre for 2014. This was an increase of \$380 per acre or 22% higher than a year ago, according to the SD office of USDA's National Agriculture Statistics Service. Cropland averaged \$3,430 per acre, an increase of 20% from a year ago. Pastureland was valued at \$860 per acre, up \$193 per acre from last year.
- As of July 1st, winter wheat production is forecast at 53.8 million bushels, which would represent an increase of 106% from last year's production. Average yield is forecast at 46 bushels per acre, up 7 bushels from a year ago.
- As of July 27th, topsoil moisture conditions across the state were rated 29% short to very short while subsoil moisture conditions were rated 20% short to very short.
- As of July 27th, corn condition was rated 93% fair to excellent, soybean condition rated 92% fair to excellent, and pasture and range conditions were rated 91% fair to excellent.
- As of July 1st, South Dakota's 1,000+ capacity feedlots reported 210,000 cattle on feed for the slaughter market. This was down 7% from the prior month but up 5% from a year ago.




Recent Trends in Natural Resources, Mining and Construction Employment




Recent Trends in Manufacturing Employment




Recent Trends in Trade, Transportation, and Utilities Employment




Recent Trends in Financial Activities Employment




Recent Trends in Professional and Business Services Employment












Recent Trends in Nonfarm Employment (excluding Government Employment)




Recent Trends in the Number of Units Authorized by Residential Building Permits for South Dakota




Recent Trends in the Number of Residential Units Authorized by Building Permits for Minnehaha County




Recent Trends in the Number of Residential Units Authorized by Building Permits for Pennington County




Recent Trends in the Value of Residential Building Permits Issued for South Dakota




Recent Trends in the Value of Residential Building Permits Issued for Minnehaha County






Recent Trends in the Number of New Non-Commercial Vehicles Titled




